Course description – Targets

Law is everywhere in our daily life. We hear about it everyday when we turn on the TV or the radio, but we are sometimes not able to fully understand what it is all about, for lack of knowledge in this field. This absence of basic knowledge in law may turn into a problem in the professional life. Hence having some notions of law is not only helpful, but therefore essential in most aspects of our life, whether personal (when buying a house or getting married), or professional (when signing an employment contract, negotiating a contract, or running a business).

The aim of this course is to provide the students with the most useful notions of law, under both French law and UK law, with a comparative and exemplified approach. The students will be at the center of this course, and will learn, through case studies, how to handle a law case and where to look for information. Illustration, through case studies or news, will be the most important part of this course, in order to make law the most practical and concrete possible.

After this course, the student should :

- *Be familiar with the notion of law, rights and with the UK and French legal frameworks;*
- *Be able to provide a global and synthetic vision as to the main aspects of private law;*
- *Understand legal issues and solve case study, by applying general legal principles to concrete examples both individually and in groups;*
- *Be comfortable with technical terms ;*
- *Have some notions of law that the student could re-use in his/her personal and/or professional life.*

Skills that will be developed:

- *Ability to select information*
- *Ability to qualify a legal situation with legal vocabulary*
- *Ability to identify a legal question*
- *Ability to select the correct legal rule*
- *Ability to understand and apply a legal rule*
- *Ability to draw the practical consequences of the application of a legal rule*

There is no specific requirement for this course.

Online teaching method

Assessment

- For each session : research and presentation. I will of course help the students if they have any questions.
- During each session: case studies
- The two mock trials will require a more important amount of work, on several sessions. That is why the case studies will be given three or four sessions prior to the due date.

Course outline

Notion of legal system: the norms in France

- Case studies in order to determine which norm should prevail on the other in a real-life situation, and/or illustration with the recent news

MOCK TRIAL (UK law)

- Students will have to work by groups of 4 or 5 people on UK mock trials, using the cross examination procedure

Big final case study using all the previous notions : be the lawyer and defend your client

- Aim : being able to understand the role of the lawyer
